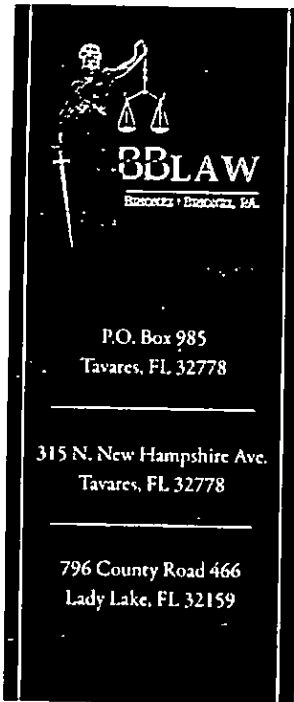

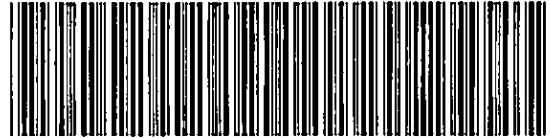

*The undersigned, being Members of Top Priority Selling LLC, adopt the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:*

**FIRST:** The name of the limited liability company filing these Amended and Restated Articles of Organization is TOP PRIORITY SELLING LLC (the "Company").

The Articles of Organization of the Company were filed with the Corporation Division of the Florida Department of State on March 11, 2019 under Document No. L19000068128.

**SECOND:** These Amended and Restated Articles of Organization were unanimously approved by the Members. The votes cast were sufficient for approval under the Articles.

**THIRD:** These Amended and Restated Articles of Organization supersede and take the place of the heretofore existing Articles of Organization and any and all amendments thereto:

**ARTICLE I**  
**NAME**

The Company reserves the right to amend, alter, change or repeal any provision contained in these Amended and Restated of Articles of Organization, in the manner now or hereafter

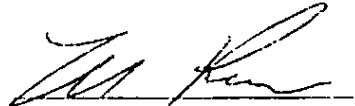

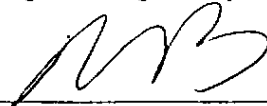
