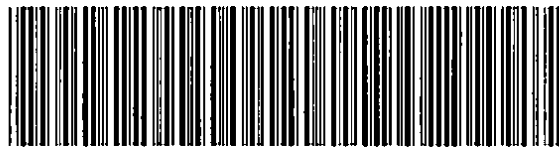

The Company is to be manager-managed. The Manager of the Company as follows:


