1. Article IV is deleted in its entirety, and inserted in its place shall be:



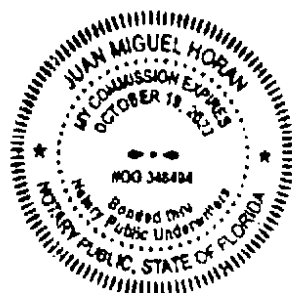


