ARTICLE II - PRINCIPAL OFFICE

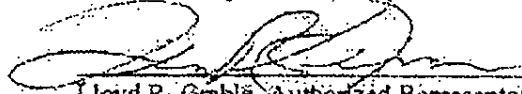
The mailing address and the street address of the principal office of the Company is 7207 Maple Avenue, Takoma Park, Maryland 20912.
