ARTICLES OF ORGANIZATION

I, the undersigned, hereby form and create a limited liability company pursuant to Chapter 605 and Florida Statutes §605.0201 of the laws of the State of Florida, and do hereby execute and adopt these Articles of Organization to be filed with the Florida Department of State and do hereby state and certify the following:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

In accordance with Florida Statutes §605.0112, the limited liability company's name shall be "FL Keys Property Services, LLC".

ARTICLE II - PERIOD OF DURATION OF LIMITED LIABILITY COMPANY

The remaining members of this limited liability company are specifically given the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of an event which terminates the continued

ARTICLE VII - COMPOSITION OF MANAGEMENT
