

## THE NORFUS FIRM PLLC (A Florida Professional Limited Liability Company)

The undersigned, desiring to form a Professional Limited Liability Company in the State of Florida pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, and Chapter 621, governing Professional Service Corporations and Limited Liability Companies, hereby certifies:

## ARTICLE I - NAME

The name of the limited liability company shall be THE NORFUS FIRM PLLC, hereinafter referred to as the "Company".

### ARTICLE II - ADDRESS
