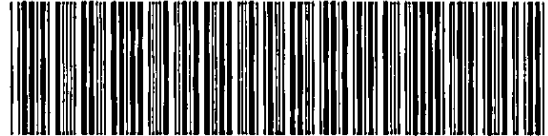

MEETING OF MEMBERS**

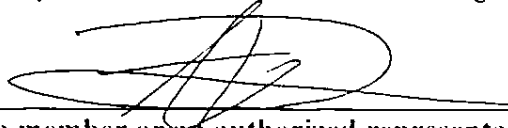
