

ARTICLES OF ORGANIZATION OF Q-JUICE, LLC

The undersigned, Quinton D. Studer, a natural person competent to confirmate and authorized representative of Q-JUICE, LLC, hereby presents these Articles of Organization as the Articles of Organization of Q-JUICE, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME
