ARTICLES OF ORGANIZATION
OF

The Articles of Organization of AIR 121 LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on March 29, 2019 under Document Number L19000084256. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The mailing address and the street address of the principal office of the Company is 2220 County Road 210 W, Suite 108, PMB 404, Jacksonville, Florida 32259.


ARTICLE III - REGISTERED OFFICE AND AGENT
