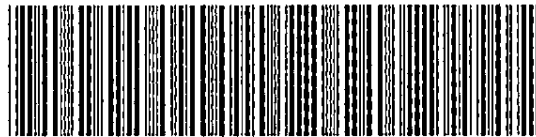

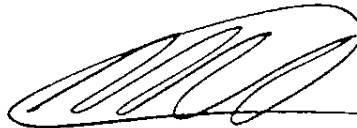
ARTICLE X - CONTINUATION OF BUSINESS OPERATIONS

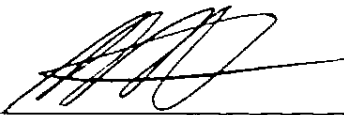
