5. 6. 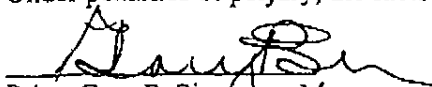

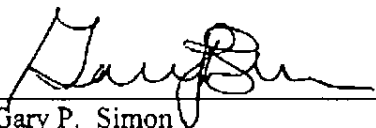
