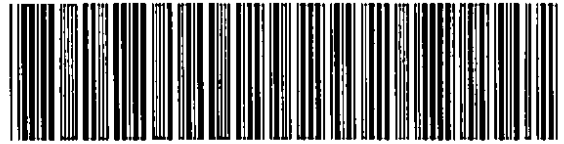




1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is Dionus, Inc. *D15-22032*

Operating Agreement


