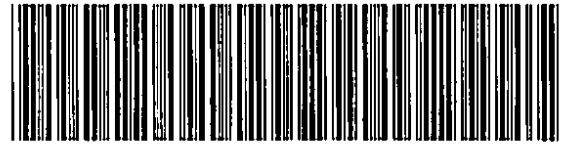




1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is Ybor City Cigar Company, Inc. *094-90912*

Operating Agreement




