ARTICLES OF ORGANIZATION

The undersigned person under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME


ARTICLE X - AMENDMENT OF ARTICLES OF ORGANIZATION
