#### ARTICLES OF ORGANIZATION **OF** JKM ROCCA, LLC

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State.


### <u>ARTICLE III</u> INITIAL REGISTERED OFFICE AND AGENT

#### <u>ARTICLE IV</u> OPERATING AGREEMENT
