I would like to make some clarification.

2. On 3/23/19 I changed the business entity name to The Van Tran, LLC by adding my middle name. On 3/28/19 I received another rejection email stating A business entity may not serve as its own registered agent. I want to confirm that the business entity The Van Tran, LLC is NOT serve as its own registered Agent. The Van Tran is an individual and serves as a registered agent and is a MGR for a business entity The Van Tran, LLC.
3. I am using my home address for the LLC; therefore, the business entity and the registered agent and/or MGR individual have the same address.
4. On 04/02/19 I received a third rejection email stating I failed to make the correction requested on 3/23/19 email. I did make the correction by adding "Van" to distinguish the document name and I'm (The Tran) is an individual to serve as a registered agent with a title as MGR for the business entity The Van Tran, LLC
