ARTICLES OF ORGANIZATION OF

ARTICLE I
NAME

The name of this Limited Liability Company shall be SMART BLUE 2 LLC (the Company).

NEW MEMBERS

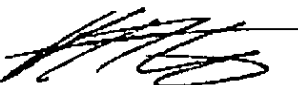

TO CONTINUE BUSINESS

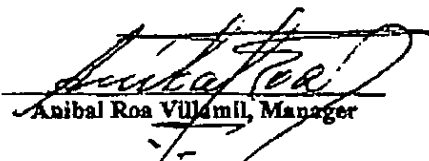
The Company shall be terminated and dissolved upon:
