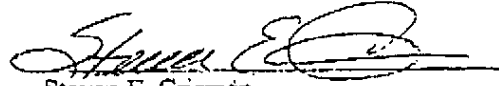

#### ARTICLE V - MANAGEMENT

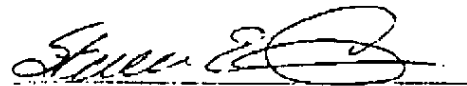
