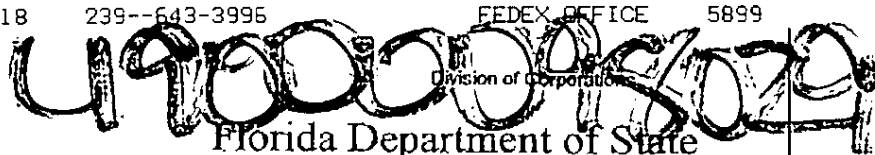

The mailing address and street address of the principal office of the Company shall be 1615 Trade Center Way, Naples, Florida 34109.

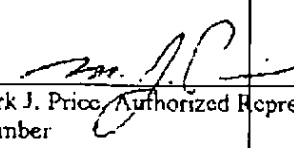
**ARTICLE IV - DURATION**
