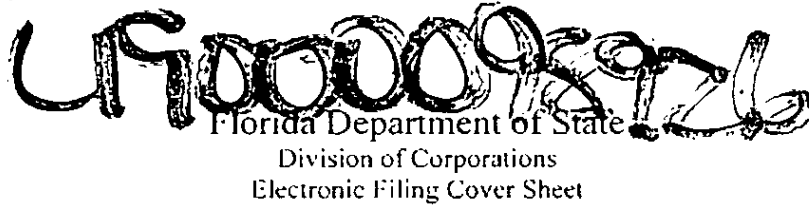


ARTICLE IV
