ARTICLES OF ORGANIZATION

OF

MARC L. FAUST, PLLC

The undersigned Authorized Representative to these Articles of Organization, a natural person competent to contract and legally authorized to practice the profession of law in the State of Florida, hereby proceeds to form a professional limited liability company in accordance with the Florida Professional Service Corporations and Limited Liability Companies Act, and hereby adopts the following Articles of Organization for such Company:

ARTICLE I. NAME

The name of this professional limited liability company is Marc L. Faust, PLLC (hereinafter "Company).

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of the Company is 901 Ponce de Leon Bouleyard, Tenth Floor, Coral Gables, Florida 33134.

ARTICLE III. PURPOSE

The purpose of the Company and the nature of its business are as follows:

- 1. To engage in the practice of law as a professional limited liability company and to provide services incident thereto.
- 2. - 3. The services of this Company which consist of the practice of law shall be carried out only through officers, employees and agents who are active members of the Florida Bar in good standing and licensed in Florida to render the service of law.
- 4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida, by the Rules Regulating the Florida Bar, or by the provisions of these Articles of Organization.

ARTICLE IV. MEMBER(S)

No person shall be a Member of the Company unless the person is duly licensed to practice law and is an active member of the Florida Bar in good standing. The initial and sole Member of the Company is as follows:
