The undersigned, being an authorized representative of Around the Bend Nature Tours, LLC, a Florida limited liability company the ("Company"), in accordance with the provisions of Chapter 605 Florida Statutes, hereby amends the Company's Articles of Organization as set forth below:

1. The name of the Company is Around the Bend, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective April 18, 2019.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:


"ARTICLE I.  
NAME

The name of the Limited Liability Company shall be Around the Bend Nature and Discovery Tours, LLC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
