The articles of Organization were filed on April 15th, 2019 by Carline Williams who I paid to file the articles on my behalf. Carline Williams was hired in April 2019 and it was within this capacity that she was listed as the registered agent for the Company at that time. Please see her details are below:

Sometime in early February 2020, I notified Carline Williams to cease and desist from any further representation of my company - Dr. Pressure & Carpet Cleaning LLC. On Sunday, February 21st, 2021, I tried to file my company's annual report and was unable to complete the filing as it was already filed by Carline Williams and Moris Lugo, except that my information was removed as the Manager for my company on the Sunbiz.org website. Additionally, I also saw that a Moris Lugo, was added as a registered Manager for my business. Mr. Lugo is unknown to me and does not work for or represent Dr. Pressure Carpet & Cleaning LLC in any capacity. Please see his details below:

On making these discoveries, I immediately contacted Carline Williams by phone to inquire about the changes and unauthorized filing. I again notified Carline Williams that she was not authorized to act on behalf or that of my company. It was at that time, that Carline Williams told me that I would have to pay her company in the amount of \$650.00 plus \$400 in order for her to amend the annual report with my details. Mrs. Williams also informed me that her company business is to acquire businesses that have not filed annual reports and maybe inactive to later sell them back to the owner or any other party for profit.

I made an appointment to go to her office to resolve the situation on Tuesday, February 23rd. I was accompanied by my business partner, Allison Hunte. Mrs. Williams informed us both that our conversation was being recorded and that we would need to pay her \$650.00 plus an additional \$400.00 to reclaim the business. We refused and left the office after requesting she return all the business receipts that were provided to her in order to file 2019 taxes. Mrs. Williams refused to return the files and have any further conversation.

On Wednesday, February 24th I went on sunbiz to file an amendment to the annual report and discovered that Carline Williams had voluntarily dissolved Dr. Pressure & Carpet Cleaning LLC. without my authorization on that same day.

Please accept this statement of facts as evidence that the voluntary dissolution was filed by Carline Williams who is not a representative for my business and had no authorization to so. Her actions are fraudulent and I have all intentions of taking her business to Court for damages.


