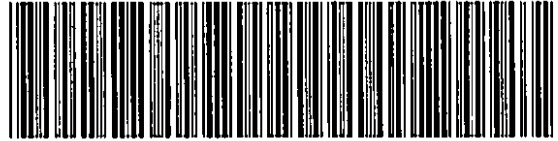




ARTICLE VII


