1. I have personal knowledge of each of the facts set forth in this Affidavit and provide this Affidavit regarding my recent filing with the Department of Corporations referenced above.
2. I am over the age of eighteen (18) and competent to testify as to the matters set forth herein.

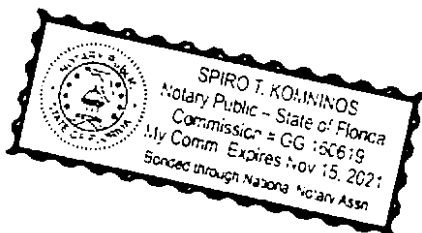


