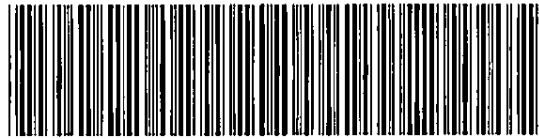

NAME. The name of the limited liability company is Radiance Media Group, LLC.

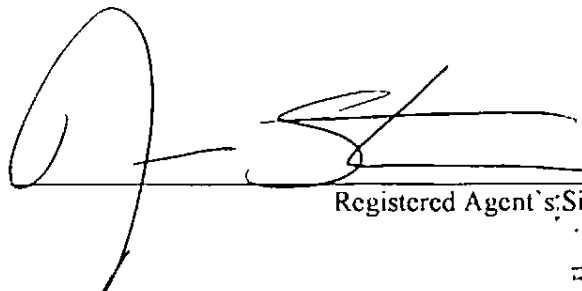
ARTICLE II.

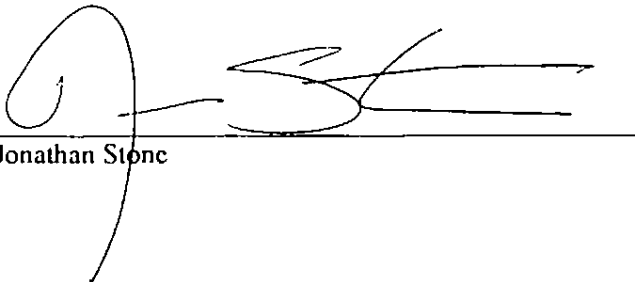
