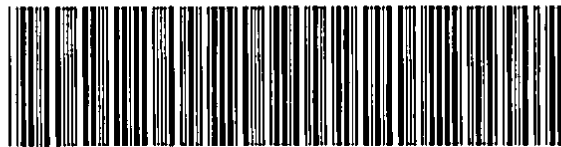



ARTICLES OF ORGANIZATION
FOR


