ARTICLES OF ORGANIZATION  
OF  
IPS FASTLINK, LLC

The undersigned, being a duly authorized representative of a Member, desiring to form a limited liability company under and pursuant to the Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is IPS Fastlink, LLC (the "Company").

ARTICLE II

ADDRESS

The principal office and mailing address of the Company is:

ARTICLE III

#### ARTICLE IV

##### MANAGEMENT

The Company shall be conducted, carried on, and managed by three (3) Managers. The Managers shall also have the rights and responsibilities described in the Operating Agreement of the Company. The Managers shall serve in such capacity until their successors are duly elected and qualified. The initial Managers of the Company shall be Bradley Mansilla, Horst Behm and Juan Serna, whose mailing address is 8111 N.W. 33<sup>rd</sup> Street, Doral, Florida 33122.

#### ARTICLE V

##### DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State of Florida, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of all of the ownership interests.

#### ARTICLE VI

##### PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE VII

##### ADDITIONAL MEMBERS



OPERATING AGREEMENT


