**ARTICLES OF ORGANIZATION
for
PLAKON INVESTMENTS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Plakon Investments, LLC ("Company").

ARTICLE II - STREET ADDRESS

The street address of the principal office of the Company shall be 1015 Tufton Cove, Lake Mary, Florida 32746.

ARTICLE III - MAILING ADDRESS

The mailing address of the Company shall be 1015 Tufton Cove, Lake Mary, Florida 32746.

ARTICLE IV - DURATION

The Company is to exist perpetually.

ARTICLE V - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida as specified in the Operating Agreement of the Company. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE VI - MANAGEMENT

The Company shall be managed by a Manager and is, therefore, a manager-managed company for purposes of Section 605.0407 of the Florida Statutes and other relevant provisions of Chapter 605 of the Florida Statutes.

ARTICLE VII - MANAGER(S)

The Manager is authorized to manage and control the Company and the powers and duties of the Manager shall be as specified in the Operating Agreement of the Company. The Manager shall also be known as the "President".

ARTICLE VIII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Company is: 1015 Tufton Cove, Lake Mary, Florida 32746 and the name of the initial registered agent for service of process at that address is D. Scott Plakon.

ARTICLE IX - ADMISSION OF NEW MEMBERS

Except as otherwise provided in the Operating Agreement of the Company, no additional members shall be admitted to the Company except with the unanimous written consent of the Manager

and all the members of the Company and upon such terms and conditions as shall be determined by the Manager and all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the Manager and all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent, or as otherwise provided in the Operating Agreement of the Company.

ARTICLE X - AMENDMENTS

Neither these Articles of Organization or the Operating Agreement of the Company shall be altered, amended or modified except with the unanimous written consent of the member and the Manager of the Company.

ARTICLE XI - INDEMNIFICATION

The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.

ARTICLE XII - EFFECTIVE DATE

The existence of the Company shall commence at 12:01 A.M. on April 25, 2019.
