ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

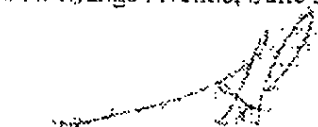

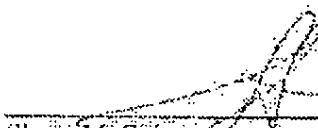
