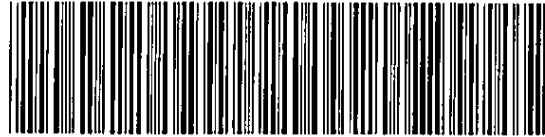

Management




