The name and address of the registered agent and office of the Company shall be **Chloe Friedman**, 20001 Barletta Lane, #2022, Estero, Florida 33928.


**ARTICLE IV**

The Company's day to day business will be managed by a manager and is therefore a manager-managed company. The initial Manager will be Chloe Friedman.


