## EXHIBIT "A" TO ARTICLES OF ORGANIZATION OF PARKWAY MAINTENANCE & MANAGEMENT, L.L.C.

ARTICLE V - Other provisions, if any.

### Written Operating Agreement

Any operating agreement entered into by the Members of the Limited Liability Company, and any amendments or restatements thereof, shall be in writing, and shall govern all matters relating to the governance of the affairs of the Limited Liability Company, the conduct of its business and the relations of its Members, including without limitation, the amendment of these Articles. No oral agreement among any of the Members or Managers of the Limited Liability Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, any written operating agreement of the Limited Liability Company, as amended and in existence from time to time.

### Voting and Non-Voting Membership Interests

The Company shall consist of one percent (1%) of the ownership interests having Voting Membership rights and ninety-nine percent (99%) of the ownership interests have Non-Voting Membership rights. The holder(s) of the one percent (1%) Voting Membership Units shall have a fiduciary duty to vote their Membership Interests based upon the same standard which applies to General Partners of a Limited Partnership in the State of Florida. In the event that the Voting and Non-Voting Membership Interest percentages specified in this Agreement do not total 100%, the difference between 100% and the sum of the various Membership Interest percentages specified above shall be allocated among the Members, in proportion to their Membership Interests in the Company, with any such allocation being in the same form of stock that any such Member currently owns (i.e. Voting, Special Voting or Non-Voting). The non-voting Members shall have rights as provided under the Florida Statutes, and as would apply to the Limited Partners of a Florida Limited Partnership. The Members may designate by written agreement and/or certificate of ownership whether Membership Interests that they are acquiring are voting or non-voting, but if not specifically designated, any issued Member Interests shall be considered to be non-voting.
