**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
HLSSII OZONA, LLC**

The undersigned authorized representative of HLSSII OZONA, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), whose Articles of Conversion and Articles of Organization were originally filed with the Florida Department of State on May 2, 2019, Document Number L19000112773, hereby adopts the following Amended and Restated Articles of Organization of the Company:

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.

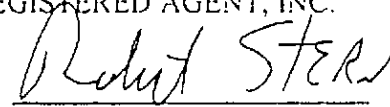
ACCEPTANCE OF SERVICE AS REGISTERED AGENT
