ARTICLES OF ORGANIZATION

MANAGEMENT

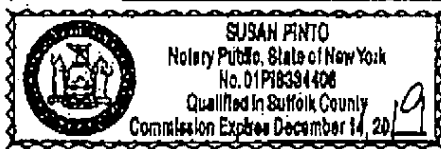
