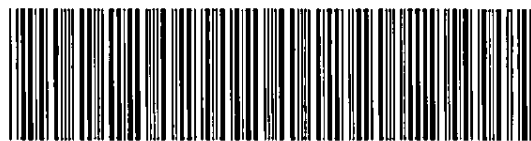

MANAGEMENT


The Company shall be manager-managed in accordance with the Company's Operating Agreement.
