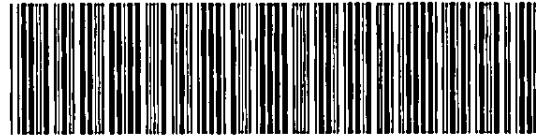

1. Name. The name of this limited liability company is International Materials Registration Technology, LLC a Florida limited liability company (the "Company").

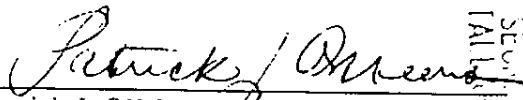
