

1. The current name of the Company is Orchard Grove Venture LLC.
2. The date of the filing of the original Articles of Organization of the Company was May 8, 2019 (the "Articles").
3. The Articles are amended by deleting Article IV in its entirety and replacing with the following:

Article IV – Management:

The Company is to be member-managed. The initial member of the Company shall be Stafford Place Praxis Limited Partnership, a Florida limited partnership, whose address is 101 SE 4th Avenue, Delray, Florida 33483.
