**ARTICLE 1: NAME AND MAILING ADDRESS**

#### ARTICLE 7: MANAGEMENT

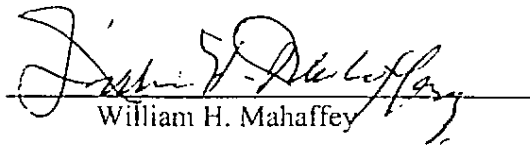
