THIRD: Adoption of the Amendment was approved by the Manager Members on September 30, 2021. The number of votes cast for the amendment was sufficient for approval.



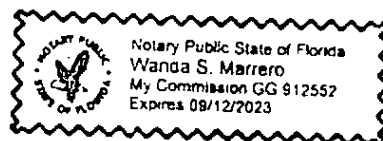
