**ARTICLES OF ORGANIZATION
OF

ARTICLE I. NAME

The mailing address and street address of the principal office of the Company shall be 5750 Collins Avenue, Apt. 15E, Miami Beach, Florida 33140.


ARTICLE III. REGISTERED AGENT AND OFFICE

ACCEPTANCE OF REGISTERED AGENT


