**ARTICLES OF ORGANIZATION
OF
DISPOZALL, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is **DISPOZALL, LLC**.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 800 East Hewett Road, Santa Rosa Beach, FL 32459, and its mailing address is 800 East Hewett Road, Santa Rosa Beach, FL 32459, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE III
MANAGEMENT**

The business of the Company shall be managed by Managers selected by the Members. **ARTICLE IV
RESTRICTIONS ON MEMBERSHIP**

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with the unanimous written consent of all members and Managers.


