

NEW MEMBERS**



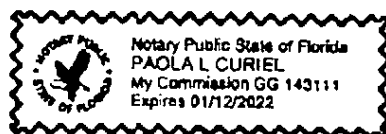
