**ARTICLES OF ORGANIZATION
OF

The undersigned hereby certifies that she is the authorized representative of the Professional Limited Liability Company named in these Articles of Organization, which is being formed under Florida Statutes Chapters 605 and 621. The following Articles of Organization are hereby adopted.

**ARTICLE I
NAME**

**ARTICLE II
DURATION; ORGANIZATIONAL DATE**

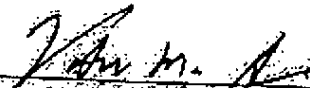
