Fraudulent Filings and Request for Recognition of Correct Entity Information – HAO NY HAO LLC (Doc No. L19000131693)

Dear Florida Department of State and Divisions of Corporations,

My name is Thi Thanh Thuy Ngo and I am the owner of Hao Ny Hao LLC

This letter is submitted as a formal statement of fact and clarification concerning fraudulent filings that continue to affect our company, originally and legally registered as HAO NY HAO LLC (Document Number: L19000131693).

Following our initial Statement of Fact submitted in January 2025, we regret to inform you that a second fraudulent amendment was filed on January 27, 2025, further attempting to seize control of our company's identity, assets, and records.

1. Summary of Fraudulent Amendment Filed on January 27, 2025

The unauthorized and criminal filing submitted on 01/27/2025 included the following false and fraudulent changes:

- Company name was changed from HAO NY HAO LLC to HNH Florida Partners, LLC.
- Principal address and mailing address were changed to: 8115 61st Street North. Pinellas Park. FL 33781
- Registered agent was fraudulently updated to: Robert Kim, 3000 Clubhouse Drive, Clearwater, FL 33761
- Company members were altered illegally:
 - My name, Thi Thanh Thuy Ngo, was completely removed from the records.
 - Other lawful members of the company, Sy Hao Vang, were also removed without our consent or knowledge.

All of the above changes were submitted without authorization and are completely fraudulent, false, deceptive, and constitute identity theft.

2. Corrective Legal Filings Submitted

To rectify these unlawful actions, we have taken the following legal steps:

- On May 15, 2025, we submitted an Amendment Annual Report to:
 - Restore our correct company address and mailing address,
 - Reinstate the correct registered agent and members of the company.
- Together with this letter (dated May 16, 2025), we are submitting an Amendment to the Articles of Organization to:
 - Officially restore the legal name of the company to HAO NY HAO LLC,
 - Once again confirm the legitimate address, mailing address, registered agent, and company members.

3. Final Declaration and Request for State Action

We hereby formally declare that:

- All filings submitted on January 27, 2025, or at any other time without our authorization, are fraudulent and must be disregarded in full.
- Only the following documents represent accurate, lawful, and truthful records of our company:
 - Amendment Annual Report filed on May 15, 2025,
 - Statement(s) of Fact submitted in January 2025,
 - Amendment to the Articles of Organization submitted with this letter on May 16, 2025.

We ask that the Department recognize only these documents and invalidate all fraudulent amendments or unauthorized filings submitted by impersonators. These fraudulent activities are part of an organized attempt to harass, defraud, and illegally claim ownership of our business.

We respectfully request that our case be given full attention and that proper records be restored. We are also working with legal authorities and law enforcement to address identity theft and corporate fraud.
