Registered Agent and Office

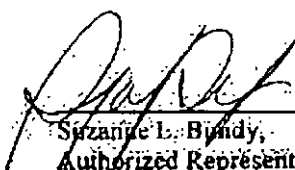

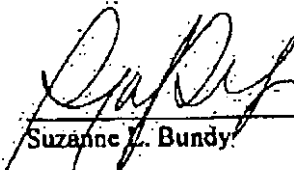

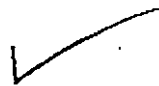
