**ARTICLES OF ORGANIZATION  
OF  
TAIBA HOLDINGS, LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopts the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is Taiba Holdings, LLC (the "Company").

**ARTICLE II. ADDRESS**
