# ARTICLES OF ORGANIZATION OF MOBILE OPTIX, LLC

The undersigned authorized representative hereby executes these Articles of Organization (the "Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

#### ARTICLE I Name

The death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event that terminates the continued membership of a Member will not cause dissolution of the Company, and the remaining Member(s), if any, have the right to continue the business of the Company, subject to the provisions of applicable law, these Articles and the operating agreement of the Company.

# ARTICLE VII <u>Amendment of Articles of Organization</u>

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
