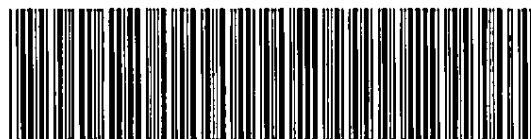

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be MANASOTA VALET, LLC ("Company").

**ARTICLE II -- ADDRESS
(Street and Mailing)**

The street address of the initial principal office and mailing address of the Company is 1460 South McCall Road, Suite 2G, Englewood, Florida 34223.

ARTICLE III -- DURATION

A Member may transfer his or her interest in the Company only as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a Member unless so approved in accordance with the terms and conditions of the Operating Agreement.


ARTICLE VI -- MANAGEMENT


