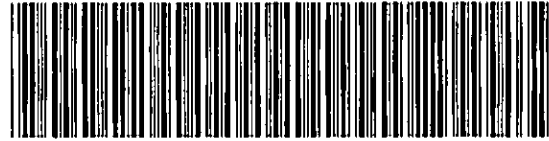



HJSH Limited Liability Company to a Corp instead of an LLC.


